Meeting Minutes March 28, 2024

1. Call to Order

President Jim Sharp called the Pierce County Fire Chiefs Association meeting to order at 9:05 a.m. remotely via Zoom and in person at South Sound 911 located at 3580 Pacific Ave, Tacoma. According to the Zoom attendee list (5) and sign in sheet (7), there were a total of 12 people in attendance.

President Sharp welcomed everyone and thanked them for attending.

2. Approval of Minutes

It was moved by Chief Thirkield and seconded by Chief Medford to approve the February 22, 2024 meeting minutes as presented. MOTION CARRIED.

3. <u>Treasurer's Report – Denise Ross</u>

See Treasurer's Report on the back side of the agenda. Chief Thirkield moved and Chief Medford seconded to approve the Treasurer's Report as presented. MOTION CARRIED.

4. Correspondence

A. Response from PCDEM re: 700 radio fees. President Sharp reported he received a brief email from Jody in that costs have not gone up. Lost funding streams and have to start charging the full rates to the users.

6. Executive Board Report

President Sharp reported what was discussed at the Executive Board is on today's Agenda and will be covered throughout the meeting.

7. Committees and Workgroups

A. Audit Committee – Morrow / Parkinson

Chief Morrow stated Parkinson is taking lead on the audit and has all the documents to review.

B. PC Code Revision Workgroup – Morrow

Chief Morrow reported he received communication from County and sent it to Chief Berdan. Mike and Kevin are working with the County on Code Revision.

C. Radio Replacement System – Sharp / Morrow

President Sharp reported new invoices from the County. 250% substantial increase due to not getting any off sets of SS monies. Issue of costs and also conversation of single system. No formal decision made. Chief Morrow stated funding SS issue park for now. More so about the system. Substantial changes in technology and disclosure

on reality of how the system is truly operating today and choices by system owners of how administering. At CPFR Board meeting Monday it was discussed and want to step into this. System Owners don't have a meeting scheduled until next year. Policymakers want to get engaged. Should Fire Chiefs take a different approach/decision than two years ago? Chief Sharp arrived at 9:15 am. Building completely backwards. No one in authority has asked us to build. Discussion followed. Fantastic result would be to get Fire and Police Chiefs in the room with Tacoma, Puyallup, and the County. The decision makers at policy level. Gig Harbor is augmenting the system by building towers which will build out capacity and give connectivity to the entire Peninsula. LMR augmented with LTE. Approach solutions in a more whole system way.

Still think going to a single system adds enough value to spend time energy on. If not, how do we move forward to fix known issues in the system? Where's the unified strategy for that? How is it coordinated? How to move some of this forward and what does it look like? Single system versus one system. Cheaper, more power and faster. Start having a different conversation with the right authorities. Frustrations with timelines and technology bypassing.

Discuss at the next meeting and come up with a position.

D. SS911 Call Processing Workgroup – Parkinson / Doan / Morrow

Chief Doan reported the meeting was cancelled. Distributed handout (copy attached) call processing time report that was emailed. Asked for call answering and call processing be defined. Call answering was already very well defined and was being tracked. Call processing took some time to get defined. Chief Morrow had calls compared and they're close. Numbers aren't that far off from what see in the system. Want transparency to get the data and not trying to get them or react to the number. Work together to come up with a strategy to fix/improve.

Reported met for endorsement of 2nd vice president shared at the last meeting. Western Board must be unanimous to endorse.

Chief Morrow is the single Chief for CPFR, Orting Valley and Graham Fire. All 3 boards have taken public positions on moving to merger in April of 2025. Still 3 separate entities.

Chief Wernet is retiring at the end of June.

<u>Criteria used for report</u> Event starts as a 911 call Time is reported at the 90th percentile Events which started as a Law Enforcement event were removed Events found to have inaccurate ANI/ALI data were removed Events incorrectly categorized were removed

Echo call types: Breathing Problems, Cardiac or Respiratory Arrest, Choking, Narcotic/Opioid arrest, Unconscious with Ineffective Breathing, Structure Fire, Sinking Vehicle

The highest priority event for a Stroke is a Charlie level call – these were included as a separate category.
